Member Education (Cofer): CFT Part-Time Organizing Campaign

Chris Cofer is the Guild appointee to CFT Higher Ed Committee and gave update on CFT campaign to get adjunct healthcare funded. Chris asked for Guild participation in "point and click" letter campaign as Senate hearing continues (https://actionnetwork.org/letters/tell-the-state-legis-lature-quality-affordable-healthcare-for-all-part-time-faculty). 1. M/S/P (Chen): approve proposed minutes from January 18, 2022

Eric pointed out that the motions attributed to him were actually the work of committees. Joanne asked Eric to email edits so they can be part of record. Eric sent in the following:

- 3) West Chapter submitted motion, amended by Wendy Bass(?), to hold the 2022 Districtwide Election hybrid"

2. M/S/P (McDowell): Contribute \$2000 to Miguel Santiago FACCC Legislator of the Year

The legislator receiving the award is Miguel Santiago. Marty amended the motion to "Contribute \$2000 to Miguel Santiago." The amendment was accepted by maker of the motion. Ruby spoke in favor of amendment. Sharon asked for clarification that the check would be made to Miguel Santiago. Motion passed by 89%.

Officer Reports

Sharon noted that in the past, much of Guild's expenditure arrangements with Staff Guild were based on precedents captured through oral history; the officers made effort to ensure that there is now a written agreement. Sharon communicated that Guild expenditure has been suppressed due to COVID, and as we shift back to having in-person meetings, those expenditures would likely resume. While is a projected drop in enrollment that could impact the Guild budget, and we should consider inflations in the forecast, as of now, the Guild is on solid financial footing.

Grace asked if we are budget for the CFT Part-Time Convention on May 1-2. Sharon noted that this is the same conference that Chris mentioned during Member Education and confirmed that we are budgeted for it.

Joanne also highlighted a round of conversations that herself, Xiao, and John McDowell had with trustees on a list of recommendations approved by Eboard. John noted that there is more work to be done.
