## CERTIFICATION OF RESULTS

In accordance with a letter of agreement between Los Angeles College Faculty Guild - Local 1521, hereinafter referred to as CLIENT and the American Arbitration Association, hereinafter referred to as A.A.A., an Election of Officers was conducted among the membership of the union.

Four thousand two hundred sixty-five (4,265) ballots were mailed to the members of the UNION on April 11, 2016. During the course of the election, an additional nine (9) members were added and fourteen (14) changes of address and/or requested duplicates were mailed out. In order for the ballots to be valid and counted, the franked, return envelopes, furnished to the members, were required to be received by the Foy Station Post Office by 12:00 midnight, Monday, May 2, 2016. Due to a close-margin in the Treasurer position and the Trade-Tech E-Board Delegates, a recount was scheduled and conducted on 5/6/16.

The CLIENT provided the A.A.A. with an alphabetical list of persons who were eligible to vote. The counting of the ballots took place at the American Arbitration Association's office at 725 S. Figueroa St., Suite 400, Los Angeles, California on Tuesday, May 3, 2016. Secrecy of the ballot was maintained at all times.


