In accordance with a letter of agreement between Los Angeles College Faculty Guild - Local 1521, hereinafter referred to as CLIENT and the American Arbitration Association, hereinafter referred to as A.A.A., an Election of Officers was conducted among the membership of the union.

Four thousand four hundred twenty-three (4,423) ballots were mailed to the members of the CLIENT on April 9, 2018. During the course of the election, an additional twenty-three (23) members were added and forty-nine (49) changes of address and/or requested duplicates were mailed out. In order for the ballots to be valid and counted, the franked, return envelopes, furnished to the members, were required to be received by the Foy Station Post Office by 12:00 midnight, Monday, April 30, 2018.

The CLIENT provided the A.A.A. with an alphabetical list of persons who were eligible to vote. The counting of the ballots took place at the LACFG 1521 offices at 3356 Barham Blvd., Los Angeles, California on Wednesday, May 2, 2018. Secrecy of the ballot was maintained at all times.

As a result of the totals, a run-off was deemed necessary in the East Campus Executive Board Delegates, the Mission Campus Chapter President, and the Districtwide Recording Secretary positions. The results are certified to be as follows:
